On February, President of ECSA World Enrique Banús and Prof. Léonce Bekemans, Member of the Board, had a long work session at the Executive Agency in Brussels. They met Ms Ute Haller-Block, now responsible for the Jean Monnet Programme at the Agency, and four of her colleagues in an open and friendly atmosphere.

After the meeting they took the opportunity for having a coffee with Luciano di Fonzo, now responsible for the Sports programme, and commented about it. At the end, Prof. Banús joked saying that ECSA World will now look for possibilities for participating in this programme.

2015 EUSA FOURTEENTH BIENNIAL CONFERENCE

ECSA United States celebrated its Annual Conference, this time on the 5-7 of March in Boston, Massachusetts.

126 panels, nearly 500 researchers and practitioners from over 250 institutions across the world participated in this EUSA event, which presented a broad diversity of topics and disciplines.

Among the highlights of the program, there was an evening plenary panel on Friday: "Neoliberal Policies and their Alternatives", followed by a keynote lecture by Thomas Piketty, "Inequality in the Europe- and what the EU Could Do About it". Immediately thereafter, there was a

reception hosted by the Journal of Common Market Studies. Two other plenaries focused on the Future of EU Federalism, and the Future of Transatlantic Relations, the latter featuring Baroness Catherine Ashton (former High Representative of the Union for Foreign Affairs and Security Policy). A panel and discussion honoring Lifetime Achievement in European Studies Award Recipient James Caporaso, former Chair of EUSA, took place on Saturday during the lunch time session.
